CONDITIONS OF HIRE

School Options and Hire Functions:

1. The Hirer undertakes to ensure that there is adequate access and area available for the equipment hired, and will also provide the required electrical supply, and own water-hoses where applicable.
2. Although every effort is made by the operators to maintain safety, it is the responsibility of the Hirer to place adequate signs, warning patrons, that the equipment is used at their own risk. Any event organizer will have to make sure that their own Public Liability is in place, as this will fall into the venues responsibility, and organize their own ride safe certificates ect. Were required. (Schools must send tear-off slips to parents)
3. Rainbow Inflatables, the agent, and any of the employees, will NOT be held responsible for the death, injury, loss or otherwise to any person using the equipment supplied, whether supplied through an Agent or not. (the hirer must make sure that premises where function is held has Public Liability in place)
4. The Hirer will be responsible for any damage to the equipment whilst it is in their possessions whether malicious or otherwise, but excluding fair wear and tear.
5. Deposits and payments made, will not be refunded due to bad weather or unexpected disaster, but every effort will be made to accommodate the hirer on another mutually agreed date and time.
6. The Hirer will be responsible for the selling of the tickets (if applicable) and for any other selling expenses.
7. Functions are based on an operating period of four to six consecutive hours per day. Extended hours can be accommodated by prior arrangement for an additional overtime fee.
8. *The Hirer undertakes to provide meals and accommodation for the staff operating the equipment when functions are situated outside of Gauteng or extend for more than one day.
9. Rainbow Inflatables reserve the right to change any item if necessary (due to breakages, damages ect) for any other item available, as long as it is of the same value or greater.
10. Supervision by an adult or trained attendant is required in attendance at all times.
11. Attendant shall make all riders aware of safety rules of the inflatable equipment.
12. Entry to the ride should be done so in an orderly and controlled manner.
13. No riders allowed on ride while it is being inflated or deflated.
14. Rainbow inflatables has the right not to inflate equipment in case of heavy winds, or deflate equipment in heavy winds or any dangerous conditions, and will not be held liable for any loss of income in that period. ALWAYS SAFTEY FIRST !!
